


According to Organic Law 1/2004, on comprehensive protection measures against gender violence (known as the Comprehensive Law), this type of violence is that which occurs as a manifestation of discrimination, inequality and power relations of men over women, and is exercised by those who are and have been their spouses by those who are or have been linked to them by similar relationships of affection, even if they do not live together.

Forms of Gender-Based Violence:

IT IS A LIFE-THREATENING HEALTH AND PROTECTION ISSUE. IT IS ESTIMATED THAT ONE IN THREE WOMEN WILL EXPERIENCE SEXUAL OR PHYSICAL VIOLENCE IN THEIR LIFETIME. DURING DISPLACEMENT AND TIMES OF CRISIS,

OTHER FORMS OF GENDER-BASED VIOLENCE INCLUDE TRAFFICKING IN WOMEN AND GIRLS FOR SEXUAL EXPLOITATION AND FEMALE GENITAL MUTILATION.

In Spain...



In 2021, there has been 39 killed women by their male partners. 5 of them were underage.

The last one has been killed by December 10th in Granada.

Since 2003 there has been 1.121 murdered women.






This chart shows the age of the victims and their alleged aggressors.

As we can see, most of women are middle-age adults

Aggressors are even older with the majority between 51 and 60 years old.



58,9% of women were between 31 and 50 years old



56,4% of alleged aggressors are between 41 and 60 years old



There has been 119.552 complaints in 2021 in Spain. From June to September 2021, victims of gender-based violence totalled 43,830, 5.58% more than in the same months of 2020. Of these, 29,098 (66.39%) were Spanish and 14,732 (33.61%) of other nationalities. The underage victims were 140 girls, 127 of them of Spanish nationality.

The courts for violence against women recorded 45,091 complaints, 5.22% more than in the same quarter of 2020 (42,854). Of these complaints, 73.22% were filed by the victim herself, most of them at the police station (72.21%).

26 children have been orphaned in 2021

Murdered women with previous complaint against their alleged aggressor.

Almost the 80% of the victims didn't report any previous complaint. Of the 8 cases with complaint 5 of them carried the proccess.

COVID-19 AND ABUSE

2020 was a difficult year in terms of gender-based violence due to the obstacles of confinement which made it difficult to present evidence or to be able to leave the house to denounce your aggressor.

In spring, at the beginning of the confinement, the number of complaints fell by almost 15% compared to 2019. If it is already difficult for the victim to take the step of reporting in circumstances of confinement, it was much more complex.

However, what did occur was an increase in calls to the 016 service against male violence as well as to the psychological care chat. They rose

to 29,700 requests, an increase of 57.9% compared to the same period in 2019.
